<i>What we've accomplished</i>	<p>West Central Wisconsin Lake Fair at Lake Wissota State Park - We had a large display and informed people about our activities. We were especially pleased to have been visited by the Director of Wisconsin State Parks, Dan Schuller, and his wife.</p>
<i>Outreach</i>	<p>Leadership in Conservation Awards - CCLC was instrumental in nominating Chippewa County Land Conservation's County Stewardship program for a national award. The county's program was recognized as the small county runner-up for the national recognition two years in a row.</p> <p>Annual Meeting - The Kemper Woods Annual Meeting in May had a record attendance for the outdoor event, despite the threat (and reality) of rain.</p> <p>Earth Day 2009 - CCLC was represented by board members at this well-attended event in Eau Claire near the campus. In addition to a younger audience, we met several elected officials as well.</p>
<i>Land Management</i>	<p style="text-align: center;">—</p> <p>Buckthorn Management at Boyd Park - Our first buckthorn management field day at Boyd Park drew a healthy participation of volunteers to identify and remove the invasive plant that has made a big impact on the park. The ability of buckthorn to totally replace all native vegetation was evident, and the resulting mountain of pulled and cut vegetation was testimony to the hard work.</p>
<i>Land Protection: New Projects</i>	<p style="text-align: center;">—</p> <p>Easements - Two easements have been in active negotiation for most of the year. A third project will be delayed until a better time for the landowner to pursue it.</p> <p>Land donations - We were disappointed to learn that the wishes of one prospective donor that we were working with will not be carried out due to the couple's unexpected passing.</p>

<p><i>Election of Directors: Elect three at Annual Meeting</i></p>	<p>Three board members will be elected at our annual meeting on May 12 at the Larrabee Lodge. Two are seeking re-election while the third is seeking election to his first full term on the board.</p> <p>John Molloy and Pat Andress have served on the board for several years (John since 2000, and Pat since 2003) and are eager to continue serving. Both John and Pat serve on the outreach committee.</p> <p>Jerry Sazama, newly appointed to the board last year, is running for a full term. Jerry retired in the fall from Chippewa County's corporation counsel office and brings a wealth of experience in working with landowners on land acquisition activity for the county. As an attorney, he provides critical advice on legal matters as well. So far, Jerry's been involved in negotiations with landowners and their attorneys on behalf of the Conservancy.</p>

<p><i><u>Protecting your land!</u></i></p>	<p>Local land trusts promote a variety of conservation options that provide permanent protection for significant areas. Most often, these options target land and water resources with natural, recreational, scenic, historic, or productive value. For conservation-minded landowners, such protection strategies are both practical and essential to preserving the land.</p> <p>In order to ensure permanent protection, a landowner may choose to donate property or a conservation easement to a land trust. An easement places protective restrictions on present and future uses while the landowner retains ownership and use of the land. In all cases, the land trust and landowner work together to create a protection strategy that meets the conservation needs of the land as well as the financial needs of the landowner.</p> <p>For more information, contact the Chippewa County Land Conservancy (723-1999).</p>

It is adjacent to another block of property on which West Wisconsin Land Trust holds a conservation easement.</p> <p>Pine, spruce, and tamarack, as well as wetland shrubs, mosses, and plants, are the predominant plants found on this property which provides a scenic backdrop for diners at the Larrabee Lodge.</p> <p>For those not wishing to venture onto the lake, we'll explore some of the colorful cultural history of the area.</p> <p>After pizza and beverages, Conservancy activities will be reviewed and board members will be elected.</p> <p>A drawing will be held for a copy of Dr. Charles Kemper's book on his life-long observations of birds in the Chippewa Valley, Birds of Chippewa Land.</p> <p>Long Lake area residents interested in the natural environment of northwest Chippewa County are especially invited to join us to learn and share their knowledge of this unique natural area.</p> <p>A few canoes and rowboats will be available, as well as personal flotation devices. You may wish to bring your own (especially PFD's). Waterproof boots or waders are also desirable for walking on the bog.</p>
